### Dear EyeBnyDlrect Customer,

At EyeBuyDirect, we care about keeping your vision sharp and your information safe. Receatly, we were made aware of an incident that may have affected the security of your personal information. We want to share what we know, steps we are taking in response and how we're helping protect customers who were affected.

### What Huppened

In June, EyeBayDirret lemmed that \$60 U.S. consumers and reported fraudulent activity on their credit eards in September 2018 and March 2019. One thing these consumers had in common was a transaction on the EyeBayDirect website, www.eyebaydirect.com. Upon recoiving this information, we immediately ratained the services of a respected cyber risk management form with expertise in digital forensics to determine whether EyeBayDirect's systems had been econycomised. The investigation concluded that our systems showed companies of intrusion(s), but investigators were unable to confirm with certainty how or when the platform had been breashed or whether any data had been necessed or taken.

Dused on these conductions, it's unclear if your information was compromised. What we do know is that our customers' privacy and information security are and will remain our top priority. That's why we're keeping you informed.

#### What Information Was involved

Investigators were amble to determine whether and, if yea, which information was compremised. If your information was accessed or taken, the information may have included details of your purchase(s) with EyollayDirect, including personal details, such as your first name, last name, shipping and/or billing address and prescription data as well as payment-related information, such as your payment and number, payment eard verification code and payment eard expiration date. Our policy is to not store any payment and information, but this information is transmitted between your browser and our servers and therefore may have been exposed to a potential intrader.

#### What We Are Doing

At EyeBuyDirec:, we take the protection of your personal information very seriously. Upon receiving the notification of a potential incident in June, we promptly took steps to validate all data flaws into and out of our systems, and we ensured that there were no unauthorized modifications to our software platform. We also retained the services of an independent cyler security firm to kelp review and update security protections across all our systems. Following immediate and condimited action, the incident has been addressed and all identified wedenesses are currently being corrected. At the same thus, we have undertaken significant investments to further consolidate the security of our platform and artigate future risks.

You are receiving this notice because you were one of the individuals who reported fraudulent charges on your credit eard. While it's unclear how or when exactly your information was compromised on www.cyebuydirect.com, it was compromised and we are slucerely sorry for that. Our enstoners' privacy and information security are and will remain our top priority, which is why we are redoubling our efforts to ensure there is no doubt about the privacy or accurity of your information.

### What Information Was Involved

Investigators were unable to determine exactly which information was accessed or taken, but it likely included details of your purchase(s) with EyeBuyDirect, including personal details, such as your first name, last name, shipping and/or billing address and prescription data as well as payment—related information, such as your payment card number, payment card varifaction
